BYLAWS

The Ministers Council Chapter for Chaplains and Pastoral Counselors American Baptist Churches USA April 21, 2020

Article I - Name

The name of this body shall be The Ministers Council Chapter for Chaplains and Pastoral Counselors, American Baptist Churches USA.

Article II – Purpose

<u>Section 1.</u> The purpose of this body is to build up the Church of Jesus Christ by sustaining and improving the professional church leadership of the American Baptist Churches USA in general, and chaplains and pastoral counselors in particular.

Section 2. To achieve this purpose this body shall:

- a. maintain professional and ethical standards of the Christian ministry,
- b. give support to the members of this body and be an advocate for them in their professional associations and in denominational life,
- c. interpret the appropriate roles of chaplains and pastoral counselors to the constituent parts of our denomination and to the local American Baptist churches,
- d. encourage the recruitment and nurture of candidates for chaplaincy and pastoral counseling,
- e. provide a means for expression and debate by members of this body on issues that affect the professional leadership of the American Baptist Churches USA,
- f. cooperate with the appropriate units of the American Baptist Churches USA in matters of mutual interest and concern including: 1) recruitment, 2) placement, 3) compensation, 4) continuing education, and 5) counseling,
- g. encourage the members of this body to fully participate in the constituent Ministers Council in their Region,
- h. give support to the American Baptist Home Mission Societies (ABHMS) and the Office of Chaplaincy and Specialized Ministries.

Article III – Relationships

<u>Section 1.</u> The Ministers Council Chapter for Chaplains and Pastoral Counselors cooperates with the American Baptist Churches USA in the purposes and objectives of that body.

<u>Section 2.</u> The Ministers Council Chapter for Chaplains and Pastoral Counselors is for those persons in relationship with the endorsing committee of the Office of Chaplaincy and Specialized Ministries, and will work in a cooperative and supportive manner with them.

<u>Article IV – Membership</u>

<u>Section 1.</u> Eligibility for membership in this body shall be for individuals who are approved or endorsed for ministry to persons in special need by the endorsing committee of the Office of Chaplaincy and Specialized Ministries, or who are retired endorsees, and who pay dues to this body.

<u>Section 2.</u> Membership in this body shall be for the calendar year.

<u>Section 3.</u> Dues for this body shall be payable at the beginning of each calendar year.

<u>Section 4.</u> Dues shall be established by the Executive Committee with the approval of this body. The privilege of voting and holding office in this body is reserved for those active members who pay dues.

<u>Section 5</u>. Membership in the Ministers Council Chapter for Chaplains and Pastoral Counselors shall cease when either:

- a. dues are not paid;
- b. An individual is no longer approved or endorsed by the endorsing committee of the Office of Chaplaincy and Specialized Ministries..

Article V – Officers

<u>Section 1.</u> Titles: The Officers of the Ministers Council Chapter for Chaplains and Pastoral Counselors shall be: a President, the immediate Past President, a Secretary/Treasurer, and at least two Members-at-large positions. All officers of this body shall be active members of this body at the time of their election.

<u>Section 2.</u> Representation and Terms of Office:

- a. The President, immediate Past President, and Secretary/Treasurer shall be elected by the body to a four-year term.
- b. At least two members-at-large shall be elected from the following constituencies by the body to four-year terms, and where possible, in two-year staggered terms:
 - 1) Military Chaplain on Extended Active Duty
 - 2) Military Chaplain not on Extended Active Duty
 - 3) Institutional Chaplain/CPE Supervisor
 - 4) Institutional Chaplain Not a CPE Supervisor
 - 5) Pastoral Counselor
 - 6) Retired Endorsee.
- c. Terms of office shall begin on September 1 of the election year.

Section 3. Executive Committee:

a. All Officers serve as members of the Executive Committee.

Section 4. Duties:

- a. The President shall:
 - 1. preside at all meetings of the Ministers Council Chapter for Chaplains and Pastoral Counselors and the Executive Committee;
 - 2. be an ex-officio member of all other committees of this body.
 - 3. Designate representation for the Ministers Council, Endorsing Committee and other boards or duties.
- b. The Secretary/Treasurer shall:
 - 1. keep an accurate record of the current proceedings of this body and the Executive Committee
 - 2. provide for the safekeeping of the records and official documents of this body
 - 3. assist the President and the Executive Committee in all areas of finance
 - 4. be authorized to sign checks
 - 5. submit financial records for an annual audit
- b. The Members-at-large shall:
 - 1. represent this body's constituents
 - 2. participate as Officers in the duties of the Executive Committee

<u>Article VI – Executive Committee</u>

Section 1. Executive Committee

- a. There shall be an Executive Committee of this body composed of the President, the immediate past President, the Secretary/Treasurer, and at least two Members-at-large.
- b. The duties of the Executive Committee shall be to:
 - 1. conduct the affairs of this body between meetings,
 - 2. appoint the committees needed to perform the work of this body,
 - 3. determine the size and term of appointed committees, and review annually the work of such committees,
 - 4. plan for the national meetings and other programs of this body,
 - 5. name representatives from this body to other organizations upon request,
 - 6. appoint a Nominating Committee which shall present a slate of officers to the body,
 - 7. fill all positions vacated between elections.

Article VII – Committees and Task Forces

<u>Section 1.</u> The Nominating Committee will make nominations reflecting geographic balance, the constituency of male/female and ethnic diversity as well as those in specialized areas of ministry of this body.

<u>Section 2</u>. Other committees or task forces may be established as the need arises.

Article VIII – Meetings

<u>Section 1.</u> The body may convene at the time of the Biennial Meeting of the American Baptist Churches USA to determine general policies, formulate recommendations, elect officers, set dues on recommendation of the Executive Committee, and adopt the budget. Persons unable to attend the Biennial Meeting may vote by absentee ballot.

<u>Section 2.</u> The Executive Committee shall meet annually and at such other times as it may deem necessary.

<u>Section 3</u>. Those present at the meeting of this body at the Biennial Meeting of the American Baptist Churches USA shall constitute a quorum. Three elected officers present shall constitute a quorum for the Executive Committee.

Article IX – Parliamentary Authority

The current edition of <u>Roberts' Rules of Order</u> shall be the manual to guide this body in all matters of parliamentary practice not prescribed in these Bylaws or special rules which this body may adopt.

<u>Article X – Amendment of Bylaws</u>

These Bylaws may be amended by a two-thirds vote of those present and voting, provided that the amendment has been recommended by the Executive Committee of this body or proposed upon written signature of fifteen (15) members and notice of such an amendment has been submitted in writing to all at least one month prior to being voted upon.
